

1. The "Bad Moon Rising Bad Beat" Jackpot will be available during all operating hours where a High Hand Promotion is not in Play. The Bad Moon Rising Bad Beat Jackpot will be shared between the Daytona Beach Racing & Card Club and the Orange City Racing & Card Club.
2. The "Bad Moon Rising Bad Beat" Jackpot will be seeded at \$10,000 with an additional \$1,000 added to the Jackpot weekly until the Jackpot hits.
3. For Texas Hold'em the "Bad Moon Rising Bad Beat" will feature a minimum qualification starting at Four-of-a-kind Aces beat and will drop one hand rank each week until the jackpot is hit.
4. For Four Card Omaha Games, the minimum Qualification will be a Straight Flush beaten which must be flopped. The minimum qualification for Omaha Games will be maintained for the duration of the promotion.
5. Both the minimum qualification and Jackpot value will be updated and available each Monday at 10:00 AM
6. Both the winning and losing players must use both of their hole cards to create the highest possible hand. For four-of-a-kind to qualify, the players hand must include a pocket pair.
7. In a "bomb pot" where two separate jackpot drops have been taken, players may win the "Bad Moon Rising Bad Beat" on **Either** Board. When running a hand twice only the main board will be eligible for the Bad Moon Rising Bad Beat Jackpot.
8. In order to be eligible a minimum of four players must be dealt in, there must be \$10 (including rake and jackpot) in the pot, and a \$2 jackpot drop must be collected.
9. Time Raked games and Mixed games are not eligible for the Bad Moon Rising Bad Beat Jackpot.
10. Only the best and second best hands meeting all eligibility requirements are eligible for the Bad Moon Rising Bad Beat Jackpot.
11. Players must play their hands independently. If any player, whether directly or indirectly involved in the hand, passes information or instructs another on how to act or reveals their hand to the other players, the Bad Moon Rising Bad Beat Jackpot will be disqualified.
12. If a player was dealt in the hand but walks away from the game having left chips on the table, they will retain their rights to their share of Bad Moon Rising Bad Beat Jackpot.
13. In the rare occurrence of the Bad Moon Rising Bad Beat Jackpot being hit on more than one game at the same time, and surveillance verifies that both hands completed the showdown at the exact same time, which is defined as all remaining players placing their cards face up on the table, the total Bad Moon Rising Bad Beat Jackpot will be divided by the number of winning games and the payout will be distributed on each game according to the percentages set forth in rule 14 below.

14. In order to collect any portion of the Bad Moon Rising Bad Beat Jackpot proper ID will be required and players must meet all verification requirements to be deemed eligible. Payouts for the Bad Moon Rising Bad Beat are as follows:

- 50% of the Payout will be awarded to the Bad Beat hand (losing hand)
- 25% of them payout will be awarded to the winner of the hand;
- 25% of the payout will be equally divided among the remaining eligible players who were dealt (defined as receiving cards) into the hand.

15. Any dispute or situation not covered by the official rules will be resolved by Poker Management in a manner deemed by them to be the fairest to all concerned, and that decision shall be final and binding on all participants. In addition, management may void any entry, and/or change, cancel, or modify this promotion at any time.

16. Management reserves the right to verify eligibility of all qualifying hands. There will be no recourse if the cards are mucked before surveillance was able to verify the hands and the community cards. Poker Management will not be permitted to reconstruct hands in any way.

17. All recipients of jackpot money shall be required to provide valid photo ID, valid TIN, and shall be issued a IRS Form W9 reflecting the amount won in the jackpot. Winners will be solely responsible for all taxes.

18. If a winner cannot provide a valid S.S. number (on W9) for all Jackpots 24% will be withheld as required by Federal Information Return. If a winner has not claimed and /or cannot provide property ID within six (6) months of winning the high hand their money will be forfeited back to the player's fund.

19. If a winning Jackpot claim occurs and is above \$5000, the Poker Room Manager, Supervisor Designated as Manager on Duty, or Floor Person will notify surveillance by telephone within 10 minutes of the winning claim. The Poker Room Manager, Supervisor Designated as Manager on Duty, or Floor person who notified surveillance will contact and notify the other card room of such a claim. In the event of phone system unavailability, communication may be conducted via two-way radio or an internet messaging system. If a winning Jackpot claim occurs and is below \$5000, the Poker Room Manager, Supervisor Designated as Manager on Duty, or Floor Person will notify surveillance by telephone within 10 minutes of the winning claim.

20. Once the winning claim has been verified, surveillance will notify the Poker Room Manager, Supervisor Designated as Manager on Duty, or Floor Person from the card room requesting verification. Upon receiving verification, the Poker Room Manager, Supervisor Designated as Manager on Duty, or Floor Person will notify the Poker Room Manager, Supervisor Designated as Manager on Duty, or Floor Person of the other card room of the outcome by telephone or via previously stated backup methods.
